

materials. The ground floor includes a spacious entrance hall leading to a bathroom with WC, a utility room, and a guest bedroom. Behind the staircase, there is a large kitchen with dining area, a living space, and access to a beautiful terrace with a unique view of Lake Lipno. The attic floor features two additional bedrooms, another bathroom prepared for a sauna, and a master bedroom with a walk-in closet.

FEATURES & EQUIPMENT

The design takes into account a range of premium features, including a wooden gable façade, a covered carport, large glazed openings, a wood-burning stove, and preparation for a sauna and solar power plant. The house is planned to include smart home technologies connected to a central system, enabling remote access control and security, as well as optimization of electric heating and lighting.


